OIL SPILL / LEAK REPORT FORM A: OB33/94 FLOWLINE

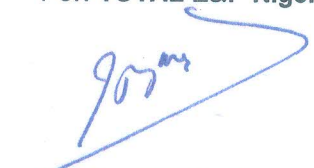
We forward herewith the Oil Spill / Leak Report Form A; duly completed in respect of the Oily water spill that was observed at OB33/94 Flowline along Idu Road in our OML58 Operational area on the 7th October, 2014 at about 06H00.

The spillage was caused by vandalism of the flowline by unknown persons using a Hacksaw at about 100 meters away from the flange. A Joint Investigation visit was carried out on the 9th October, 2014 with NOSDRA-PHC Zone participation.

An estimated volume of 2 barrels of oily water was spilled into the environment.
